**Brighton & Hove Various Controlled Parking Zones Consolidation Order 2024 Amendment
Order No.6 2026 (TRO-8a-2026)**

Brighton & Hove City Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) and (2), 4, 45, 46, 49, 53, 124 (1) (c) & (d) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as the Brighton & Hove Various Controlled Parking Zones Consolidation Order 2024 Amendment Order No. 6 2026 and shall come into operation on the 18th day of May 2026.
2. The Brighton & Hove Various Controlled Parking Zones Consolidation Order 2024 is amended as follows:

Part 4 Parking Permits

Part 4.2 - Types of Permit

Resident Visitor Permits

Delete the following paragraph

26. A Resident shall be entitled to not more than 50 Resident Visitor Permits in any 12 month period commencing from the date of issue of the first Resident Visitor Permit to that Resident or 25 Resident's Visitor Permits if the Resident resides in CPZ "Y" or "Z", or 100 Resident Visitor Permits if the Resident resides in CPZ "L", "P", "S", "U", "W", "X", "10", "11" & "12" provided that:

26. A Resident shall be entitled to a maximum number of Resident Visitor Permits in any 12-month period commencing from the date of issue of the first Resident Visitor Permit to that Resident. The maximum number is specified in Schedule 2 Part 1 Resident Visitor Permit (allocation per year) of this Order.

In Part 6.6 Delete "Low Tariff" and replace with "Seafront Area Tariff"
