

**BRIGHTON & HOVE CITY COUNCIL
ROAD TRAFFIC REGULATION ACT 1984**

**Brighton & Hove Seafront (Various Restrictions) Consolidation Order 2024
Amendment Order No.* 202* (ref: TRO-12c-2026)**

Brighton & Hove City Council (“the Council”) in exercise of its powers under Sections 1(1), 2(1), 4, 45, 46, 49, 53, 124(1) (c) & (d) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the 1984 Act”) as amended and Part 6 of the Traffic Management Act 2004 and of all other enabling powers after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order.

1. This Order may be cited as the Brighton & Hove Seafront (Various Restrictions) Consolidation Order 2024 Amendment Order No.1 2026 and shall come into operation on the 2nd day of March 2026.
2. The Brighton & Hove Seafront (Various Restrictions) Consolidation Order 2024 is amended as follows:

ARTICLE AMENDMENTS:

PART 7 – SUSPENSIONS

Delete the following:

2. Upon receipt of any request to suspend the use of any Parking Place or any part thereof in accordance with Article 1 of this Part the Council may charge such amount in respect of the implementation of that suspension as is set out in Schedule 2 Part 1a.

And replace with:

2. Upon receipt of a request made in accordance with Article 1 of this Part to suspend the use of any Parking Place or part thereof, the Council may charge a fee for implementing that suspension, as set out in Schedule 2 Part 1a.

Where a parking bay is suspended otherwise than in accordance with the required application process, a **Non-Compliance Charge**, as set out in that Schedule, may apply to reflect the additional officer time required to regularise the suspension.”
